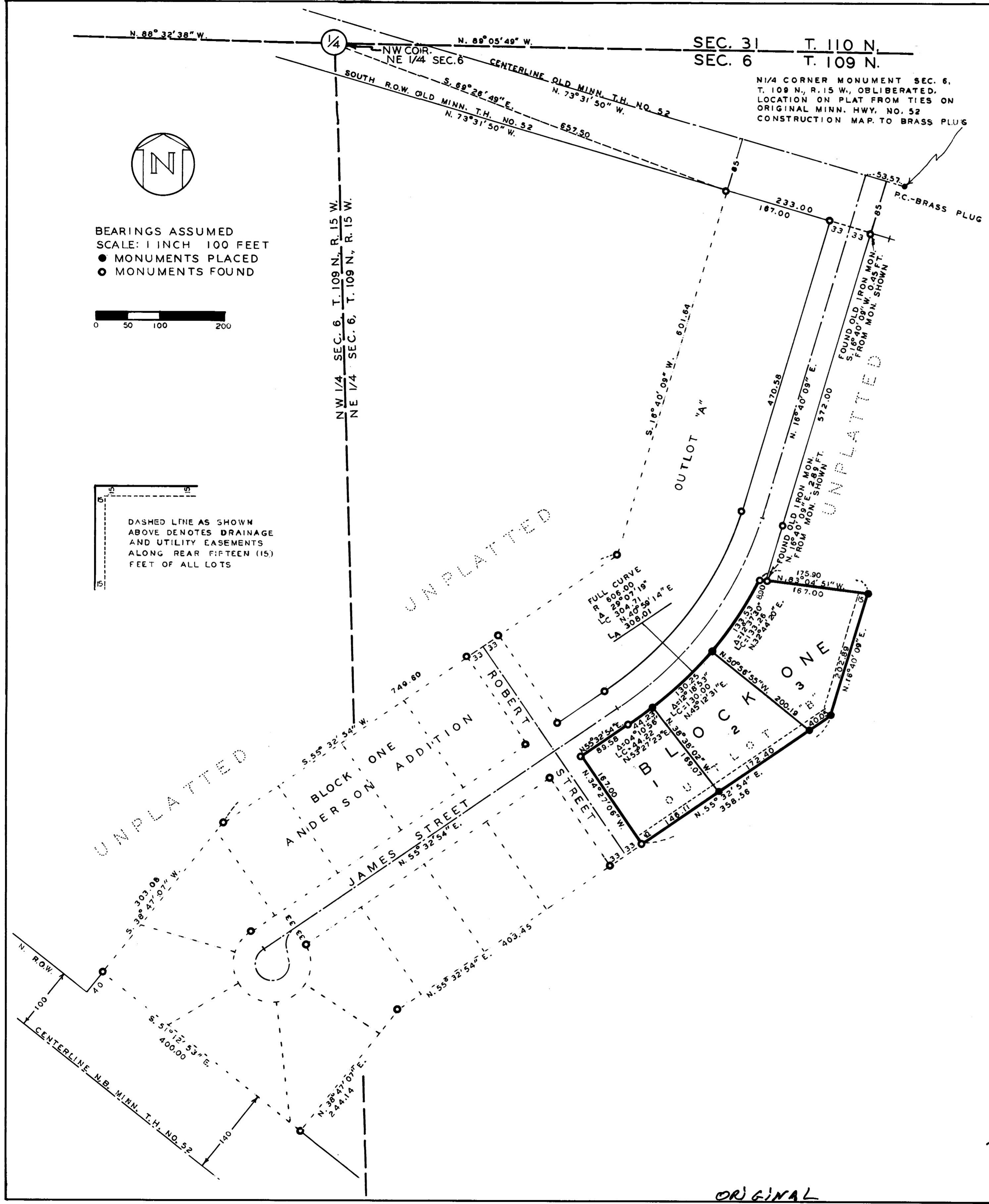
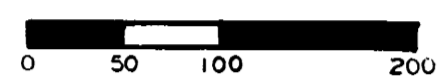


BUCK ADDITION
