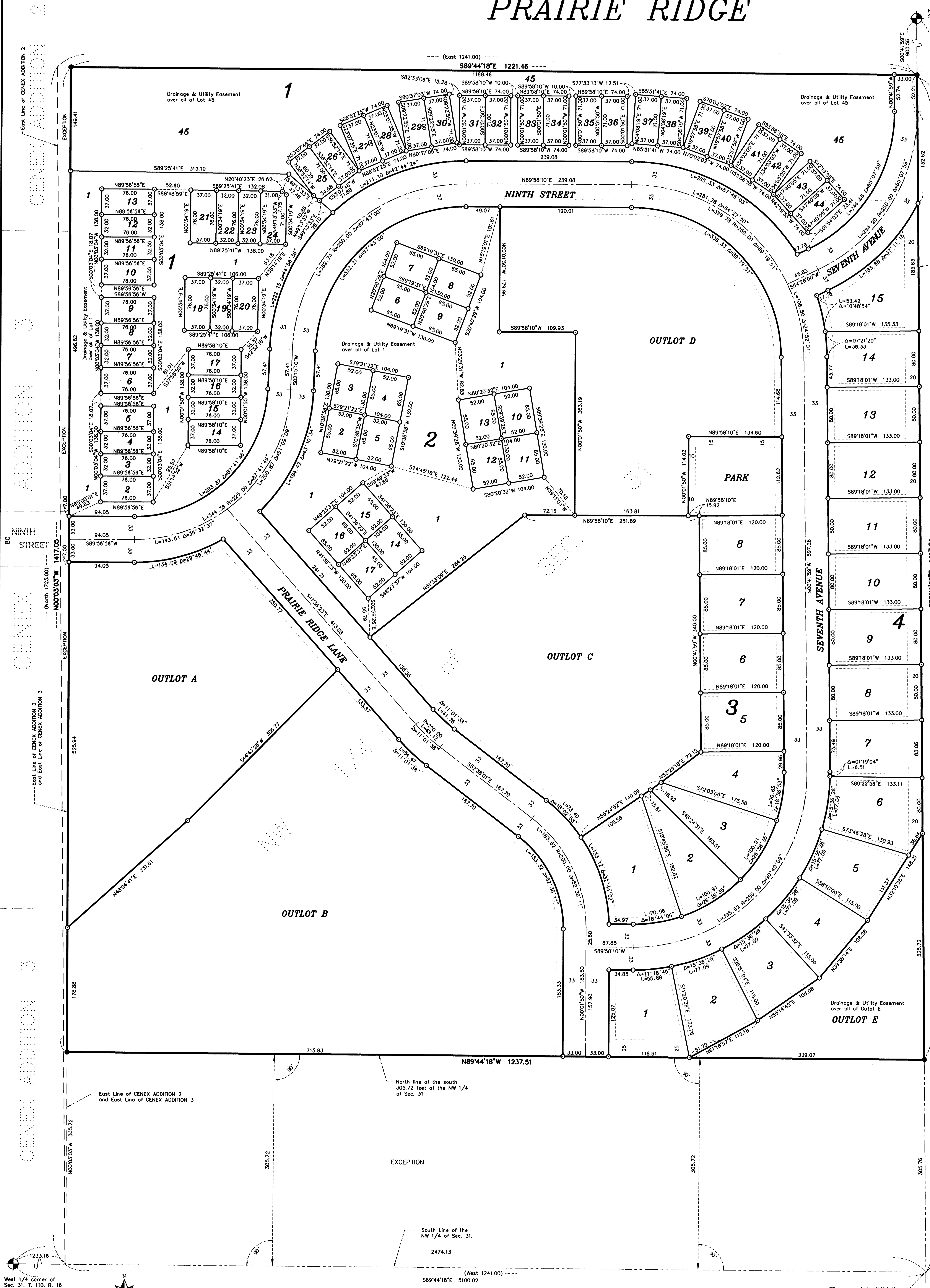


Official Plat

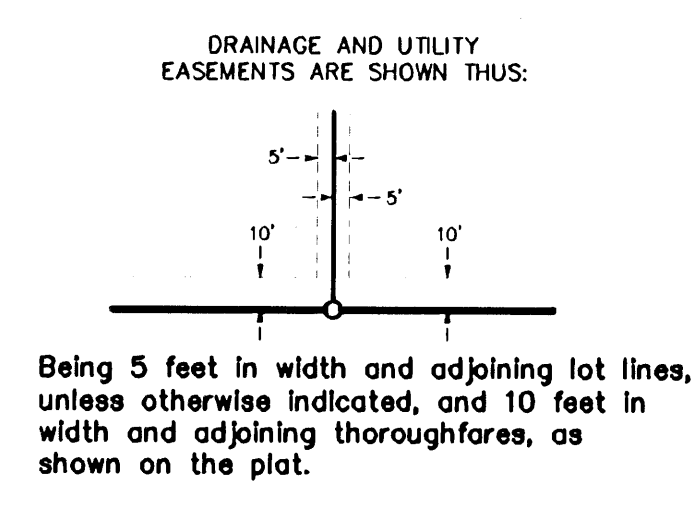
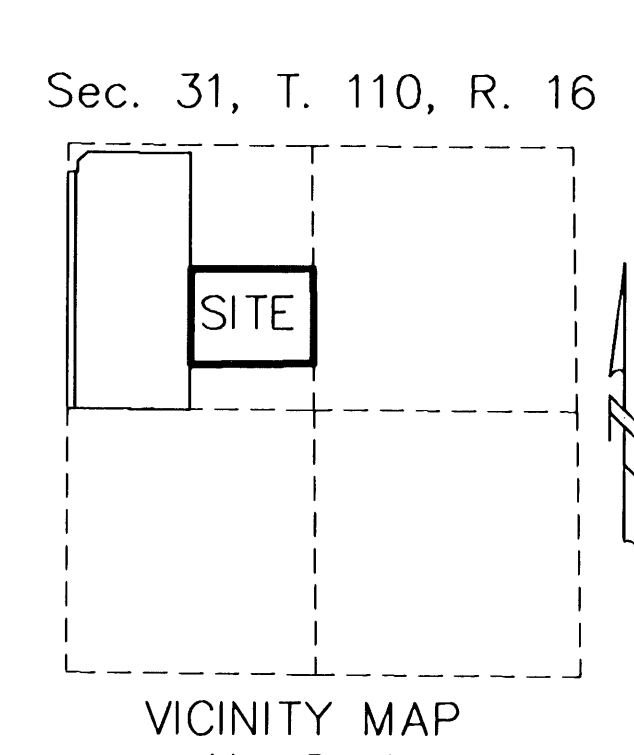
