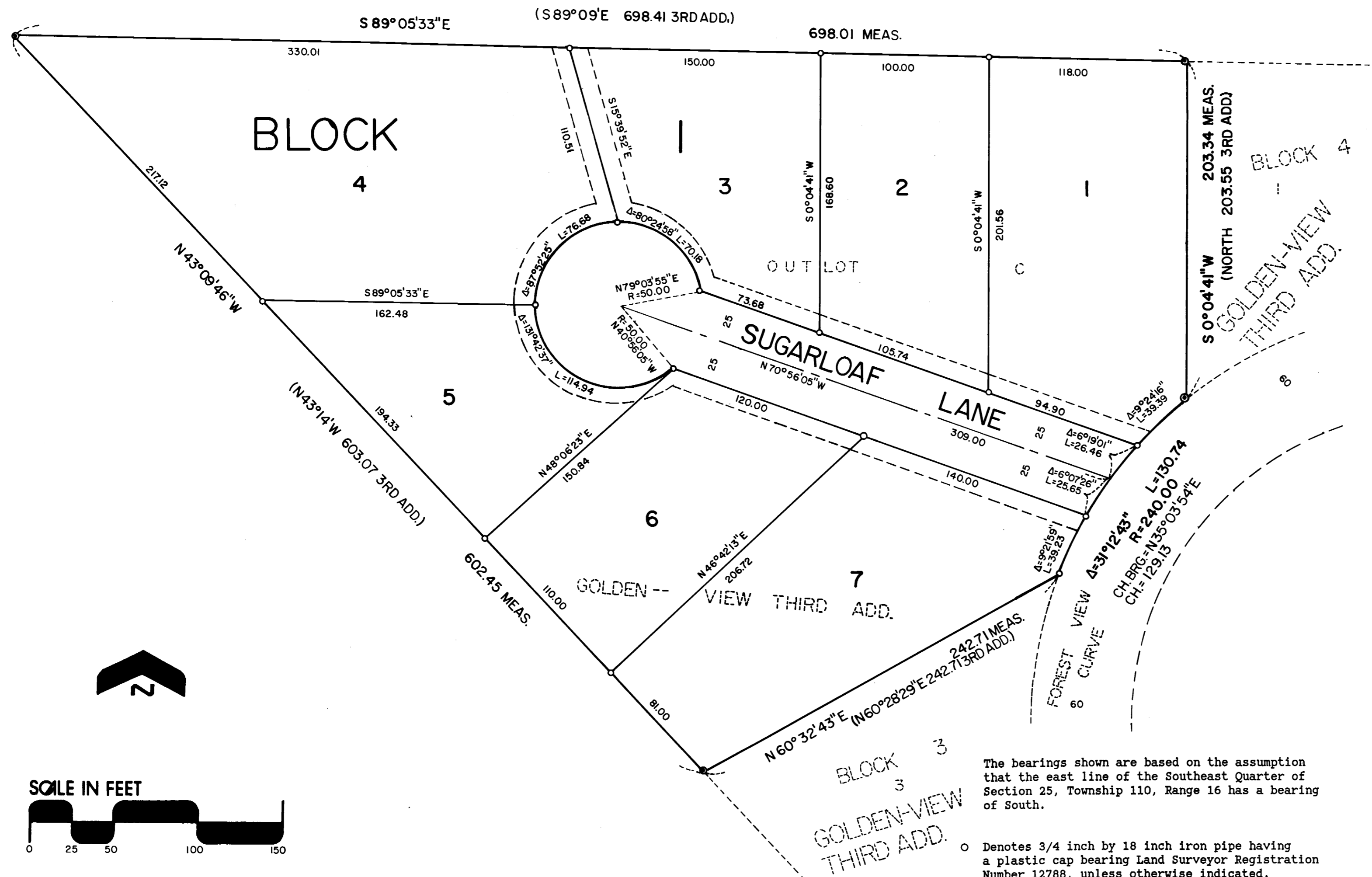


GOLDEN-VIEW FOURTH ADDITION

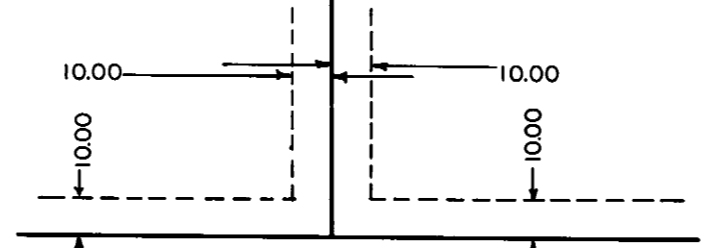
PART OF SE 1/4 OF SEC. 25, TWP. 110, RGE. 16
