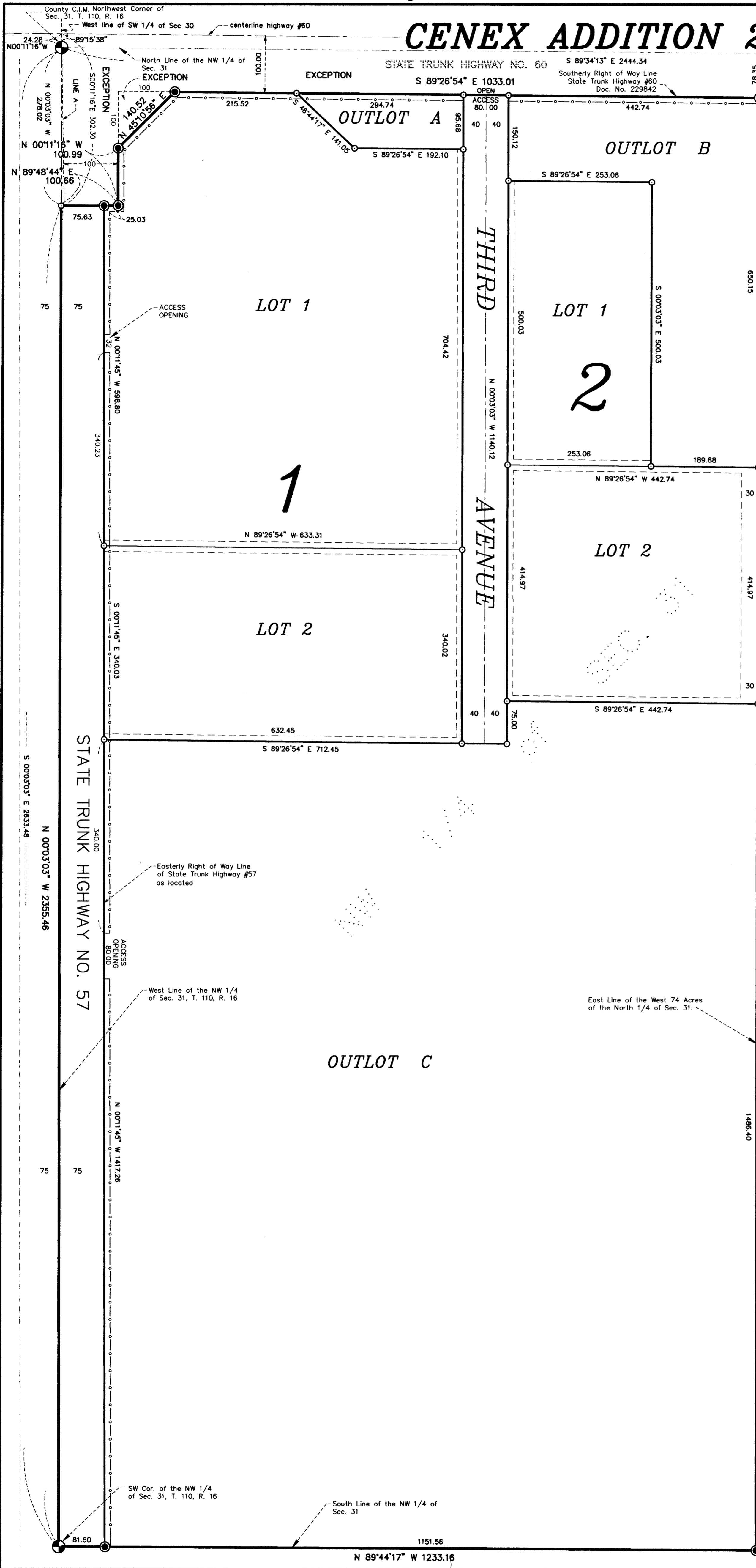


OFFICIAL PLAT

CENEX ADDITION 2



KNOW ALL MEN BY THESE PRESENTS: That Farmers Co-operative Oil Company of Wanamingo, Minnesota, owners and proprietors, of the following described property to wit:

The West Seventy Four and One-half (74 1/2) Acres of the North West Quarter (NW 1/4) of Section Thirty One (31) in Township One hundred ten (110) North, Range Sixteen (16) West of the Fifth Principal Meridian, in the County of Goodhue and State of Minnesota.

EXCEPT:

The west 74.5 acres of the northwest quarter (NW 1/4) of section 31, township 110 north, range 16 west, which lies northerly of a line run parallel with and distant 100 feet southerly of the following described line:

Beginning at a point on the west line of section 30, township 110 north, range 16 west distant 24.28 feet north of the southwest corner thereof; thence run easterly at an angle of 89 degrees 15 minutes 38 seconds with said west section line (measured from south to east) for 1500 feet and there terminating;

together with that part of the above described tract adjoining and southerly of the above described strip, which lies westerly of a line run parallel with and distant 100 feet easterly of Line A described below:

Line A. Beginning at the point of beginning of the above described line; thence run southerly at an angle of 89 degrees 15 minutes 38 seconds with said line for 302.3 feet and there terminating;

also together with a triangular piece adjoining and southerly of the first above described strip and easterly of the last above described strip, which lies northwesterly of the following described line. Beginning at a point on the southerly boundary of the first above described strip distant 100 feet easterly of its intersection with the easterly boundary of the last above described strip; thence run southwesterly to a point on said easterly boundary distant 100 feet southerly of said intersection and there terminating.

Have caused the same to be surveyed and platted as CENEX ADDITION 2, and do hereby donate and dedicate to the public, for public use forever, the thoroughfare and cut-de-sac and also dedicating the easements as shown on the plat for drainage and utility purposes only, and also dedicate to the State of Minnesota the right of access, as shown on the plat.

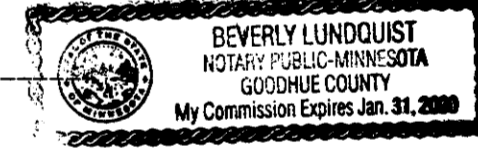

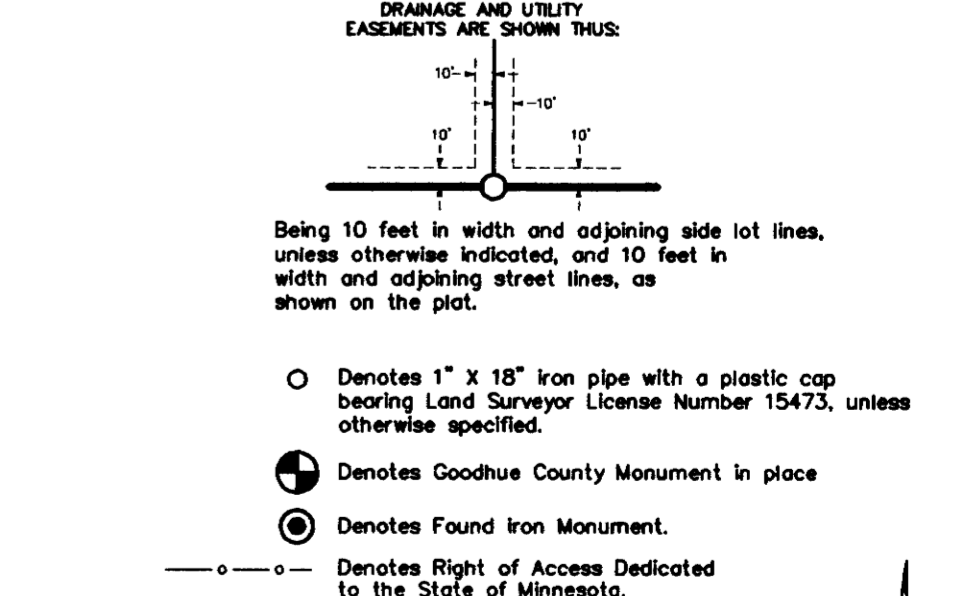
