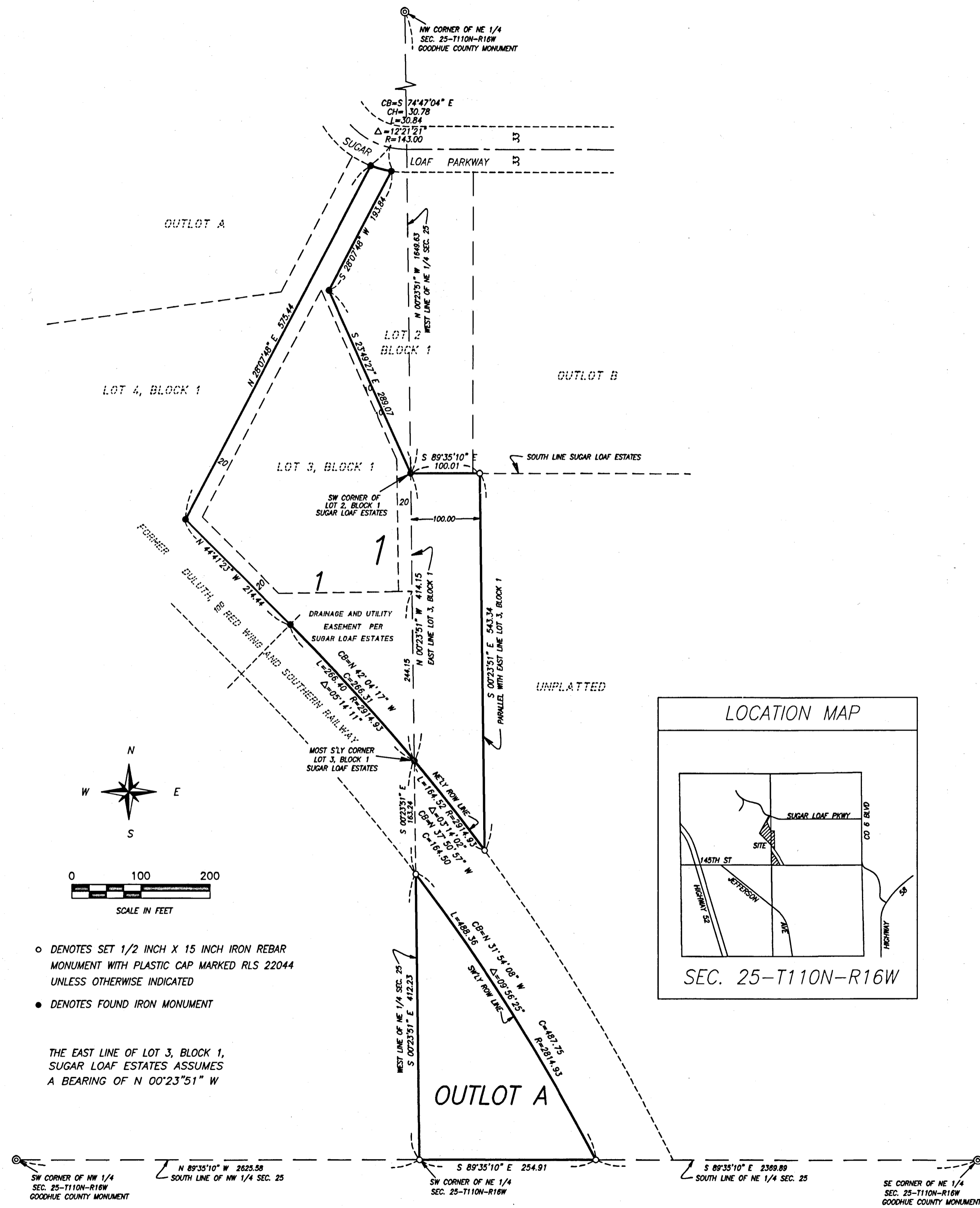


SUGAR LOAF ESTATES 2ND ADDITION



KNOW ALL PERSONS BY THESE PRESENTS: That Lawrence L. Thomforde and Sandra K. Thomforde as Trustees of the Lawrence L. Thomforde Revocable Trust and the Sandra K. Thomforde Revocable Trust, both dated December 30, 2009, owners of the following described property situated in the County of Goodhue, State of Minnesota to wit:

Lot 3, Block 1, SUGAR LOAF ESTATES, according to the recorded plat thereof, Goodhue County, Minnesota. And that part of the Northeast Quarter of Section 25, Township 110 North, Range 16 West, Goodhue County, Minnesota, described as follows: Beginning at the most southerly corner of Lot 3, Block 1, SUGAR LOAF ESTATES, according to the recorded plat thereof; thence North 00 degrees 23 minutes 51 seconds West (assumed bearing) along the east line of said Lot 3, Block 1, a distance of 414.15 feet to the southwest corner of Lot 2, Block 1, said SUGAR LOAF ESTATES; thence South 89 degrees 35 minutes 10 seconds East, along the south line of said SUGAR LOAF ESTATES, 100.01 feet; thence South 00 degrees 23 minutes 51 seconds East, parallel with said east line of Lot 3, Block 1, a distance of 543.34 feet to the northeasterly right of way line of the former Duluth, Red Wing and Southern Railroad Company; thence northwesterly, along said northeasterly right of way line, 164.52 feet to the point of beginning. And that part of the Northeast Quarter of Section 25, Township 110 North, Range 16 West, Goodhue County, Minnesota, lying southwesterly of the southwesterly right of way line of the former Duluth, Red Wing and Southern Railroad Company.
