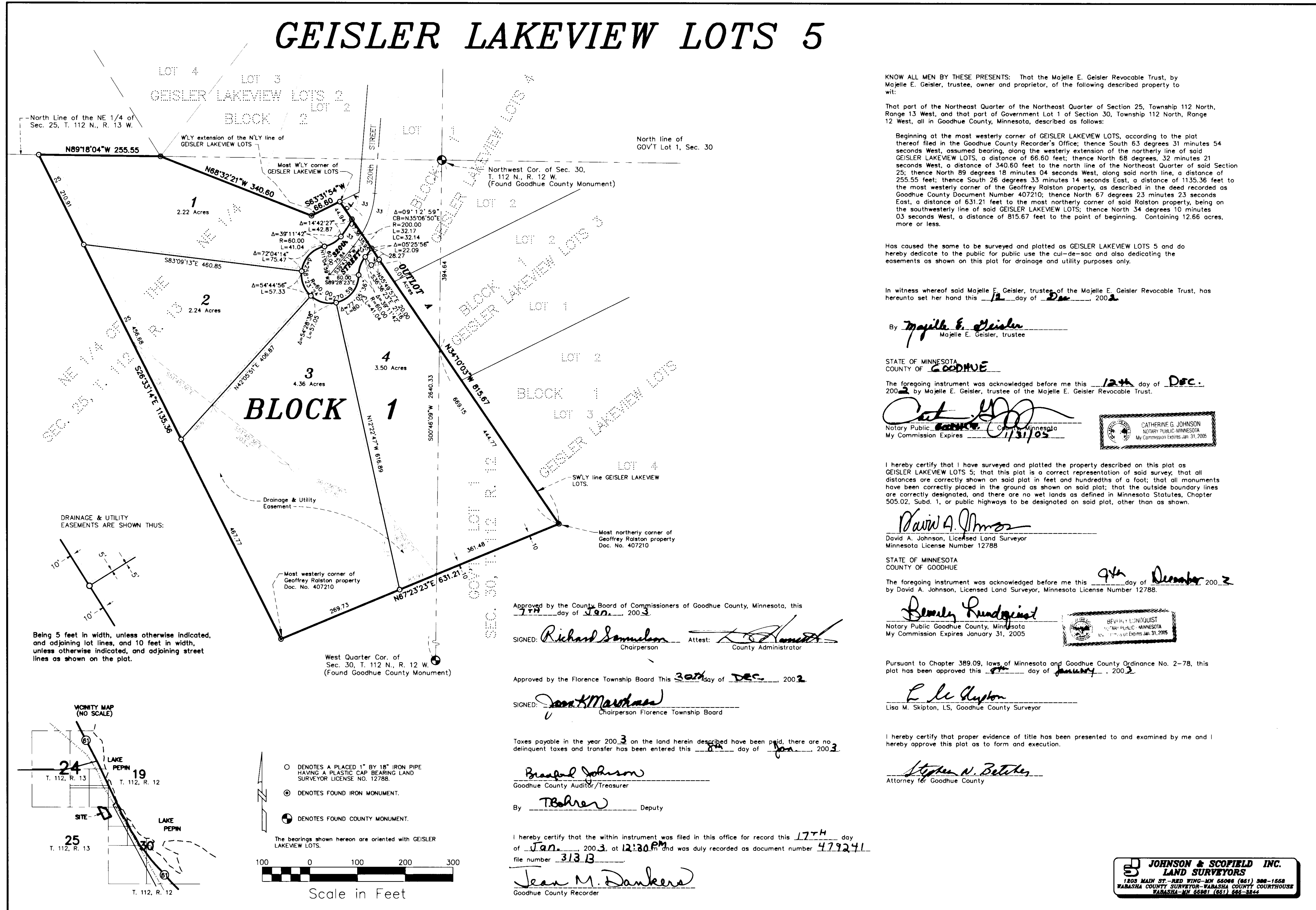


OFFICIAL PLAT

GEISLER LAKEVIEW LOTS 5



KNOW ALL MEN BY THESE PRESENTS: That the Majelle E. Geisler Revocable Trust, by Majelle E. Geisler, trustee, owner and proprietor, of the following described property to wit:

That part of the Northeast Quarter of the Northeast Quarter of Section 25, Township 112 North, Range 13 West, and that part of Government Lot 1 of Section 30, Township 112 North, Range 12 West, all in Goodhue County, Minnesota, described as follows:

Beginning at the most westerly corner of GEISLER LAKEVIEW LOTS, according to the plat thereof filed in the Goodhue County Recorder's Office; thence South 63 degrees 31 minutes 54 seconds West, assumed bearing, along the westerly extension of the northerly line of said GEISLER LAKEVIEW LOTS, a distance of 66.60 feet; thence North 68 degrees, 32 minutes 21 seconds West, a distance of 340.60 feet to the north line of the Northeast Quarter of said Section 25; thence North 89 degrees 18 minutes 04 seconds West, along said north line, a distance of 255.55 feet; thence South 26 degrees 33 minutes 14 seconds East, a distance of 1135.36 feet to the most westerly corner of the Geoffrey Ralston property, as described in the deed recorded as Goodhue County Document Number 407210; thence North 67 degrees 23 minutes 23 seconds East, a distance of 631.21 feet to the most northerly corner of said Ralston property, being on the southwestery line of said GEISLER LAKEVIEW LOTS; thence North 34 degrees 10 minutes 03 seconds West, a distance of 815.67 feet to the point of beginning. Containing 12.66 acres, more or less.

Has caused the same to be surveyed and platted as GEISLER LAKEVIEW LOTS 5 and do hereby dedicate to the public for public use the cul-de-sac and also dedicating the easements as shown on this plat for drainage and utility purposes only.

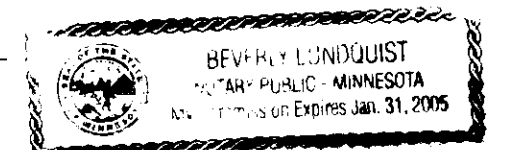

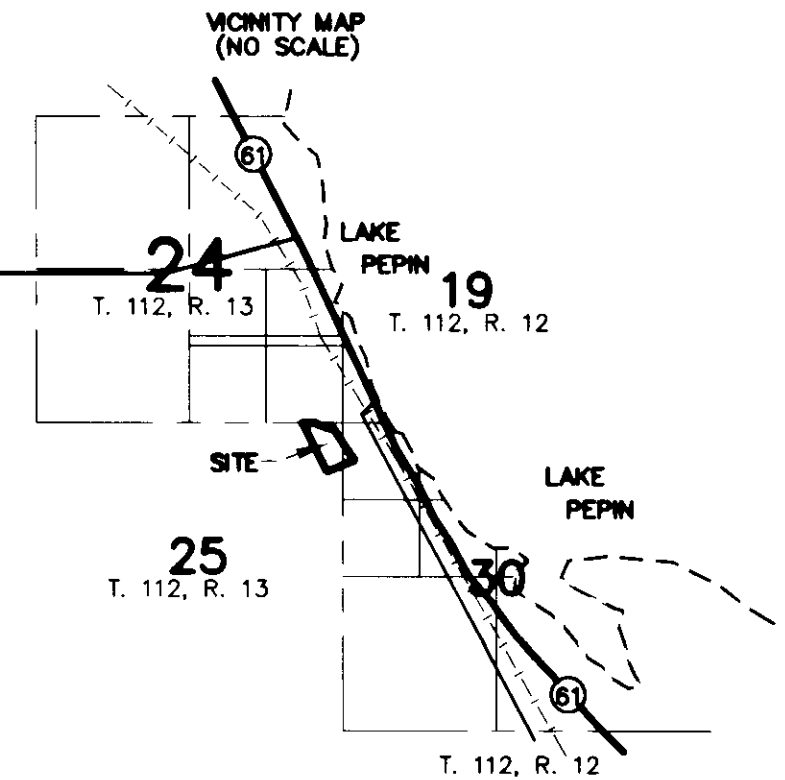
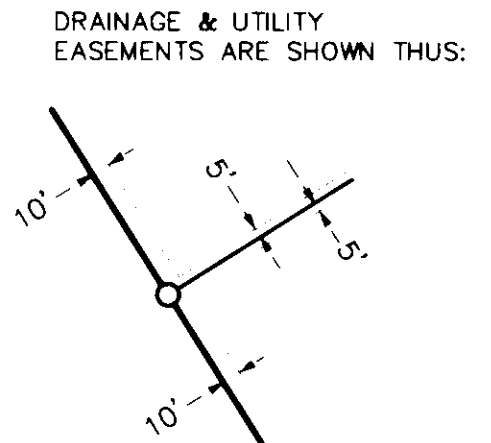
