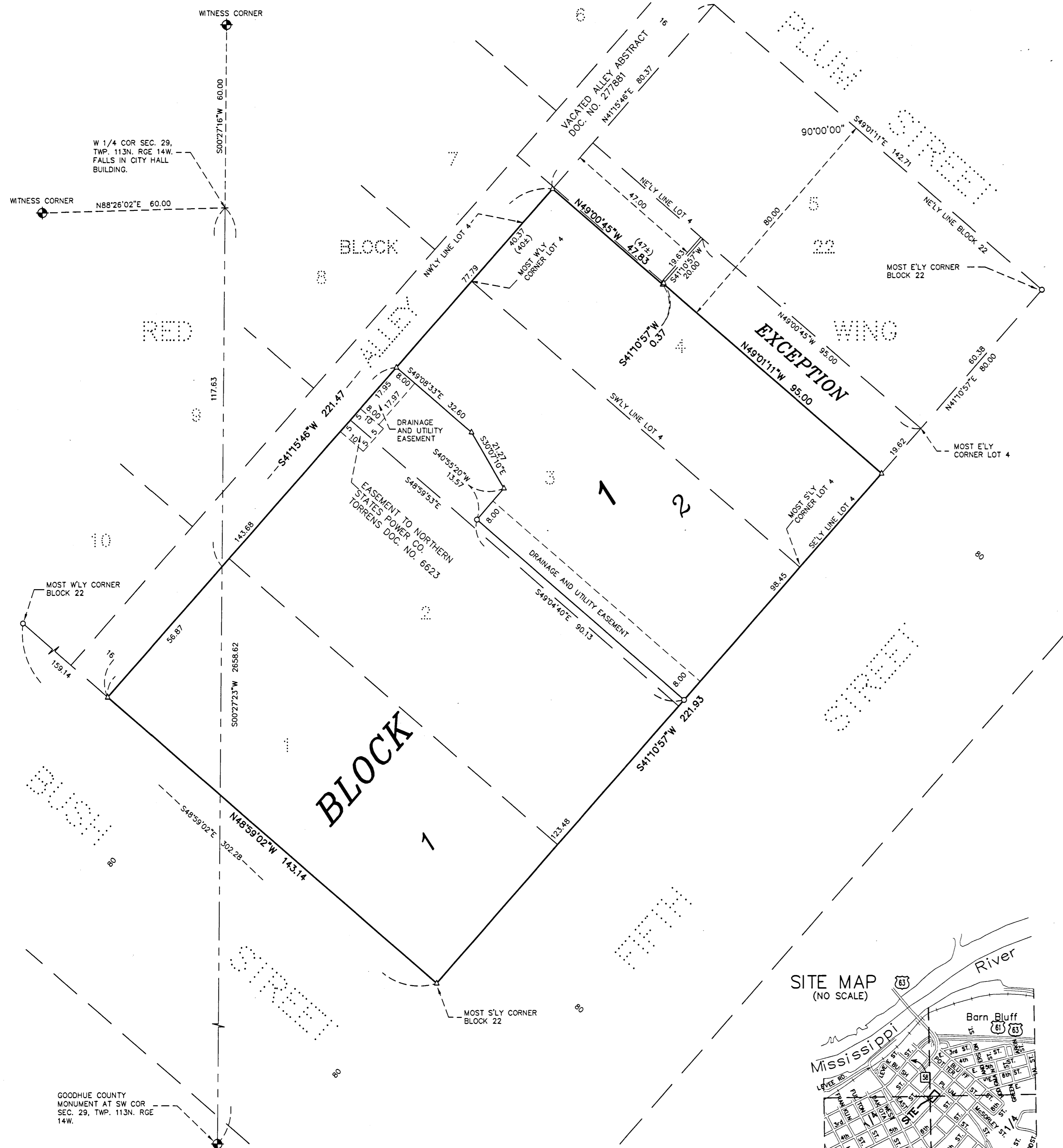


CITY HALL BLOCK SUBDIVISION



KNOW ALL PERSONS BY THESE PRESENTS: That the City of Red Wing, a municipal corporation, owners and proprietors of the following described land, situated in the County of Goodhue, State of Minnesota, to wit:

Certificate of Title No. 4119

All of Lots One (1), Two (2), Three (3) and that part of Lot Four (4) described as follows:

Commencing at the most Easterly corner of said Lot 4; thence Northwestly along the Northeastly line of said Lot 4, 95 feet; thence Southwestly, parallel with the Southerly line of said Lot 4, 20 feet; thence Northwestly, parallel with the Northeastly line of said Lot 4, 47 feet, more or less, to the Northwestly line of said Lot 4; thence Southwestly along the Northwestly line of said Lot 4, 40 feet, more or less, to the most Westerly corner of said Lot 4; thence Southeastly along the Southwestly line of said Lot 4 to the most Southerly corner of said Lot 4; thence Northeastly along the Southeastly line of said Lot 4 to the point of commencement; all in Block Twenty-two (22), Red Wing, according to the recorded plat thereof. EXCEPT: That part of Lot 4, Block 22, of the original Plat of RED WING, according to the plat thereof filed in the Goodhue County Recorder's Office, which lies Northeastly of a line parallel with and distant 80.00 feet Southwestly of the Northeastly line of said Block 22, as measured at a right angle to said Northeastly line; EXCEPT the Northwestly 47.00 feet thereof.

Has caused the same to be surveyed and platted as CITY HALL BLOCK SUBDIVISION and does hereby dedicate to the public for public use the drainage and utility easements as created by this plat.

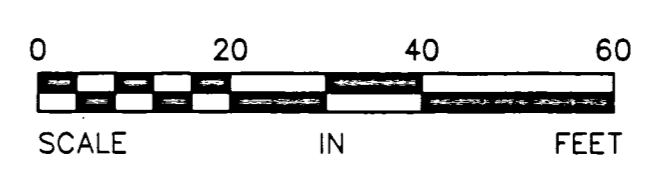
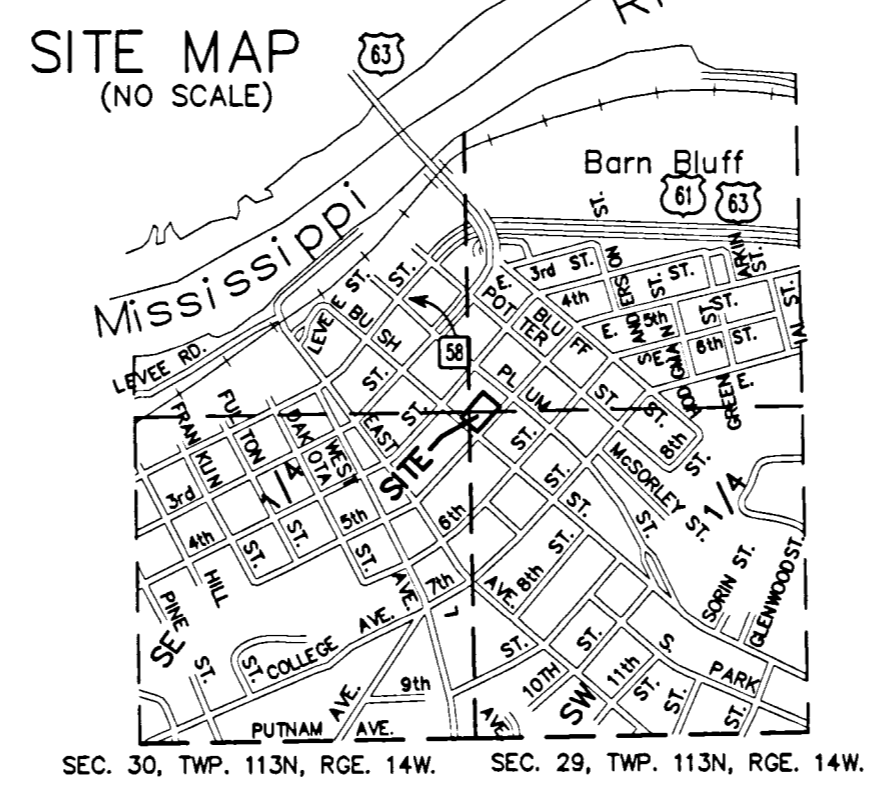
