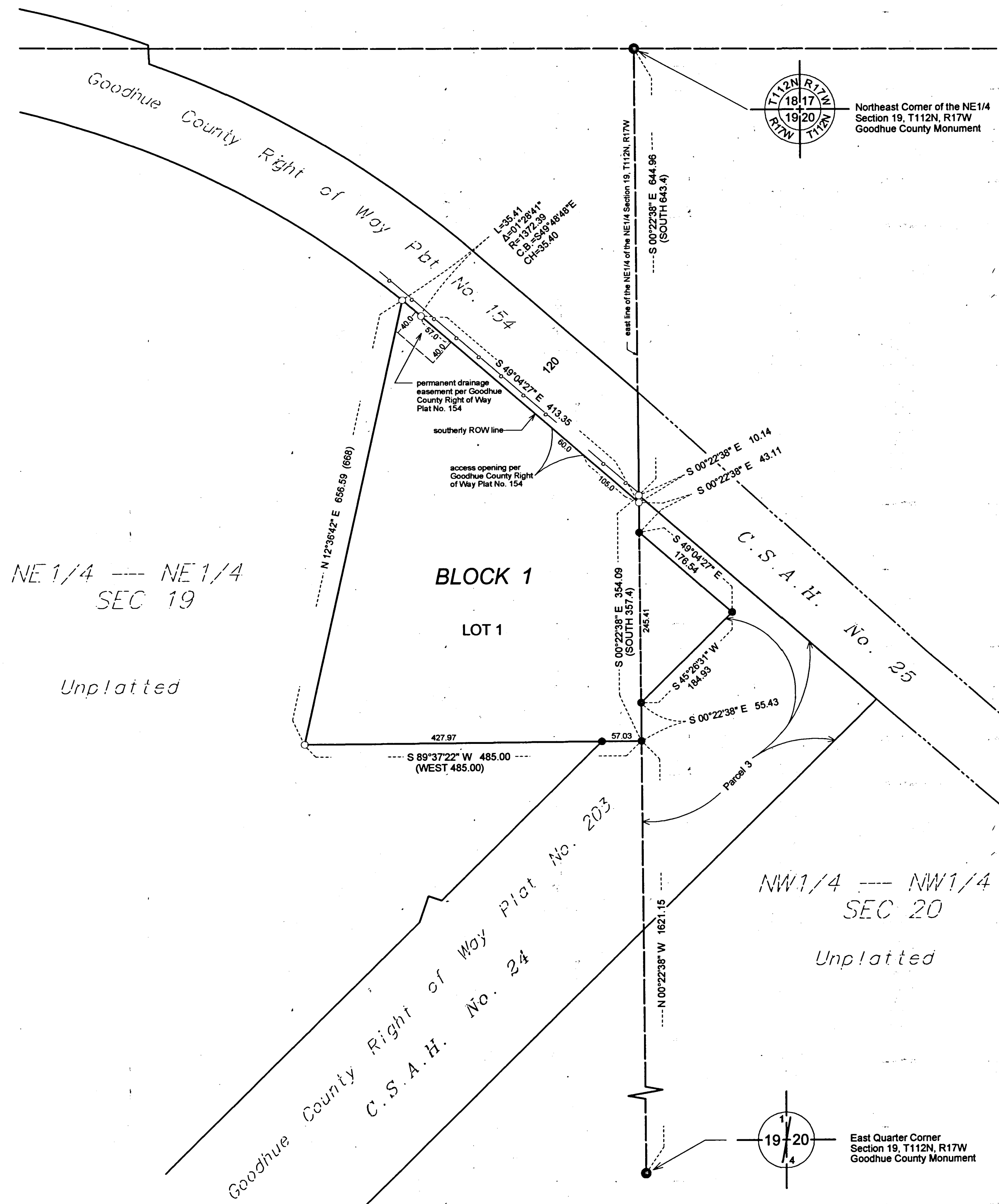


TRAPP ADDITION

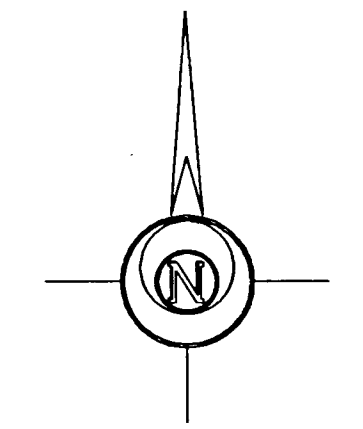
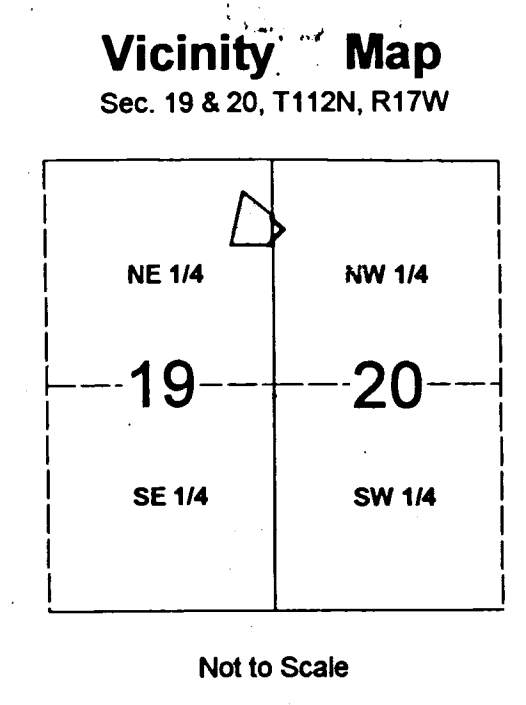
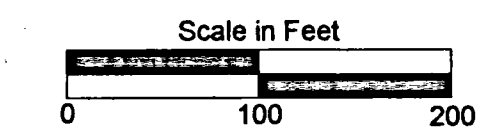
