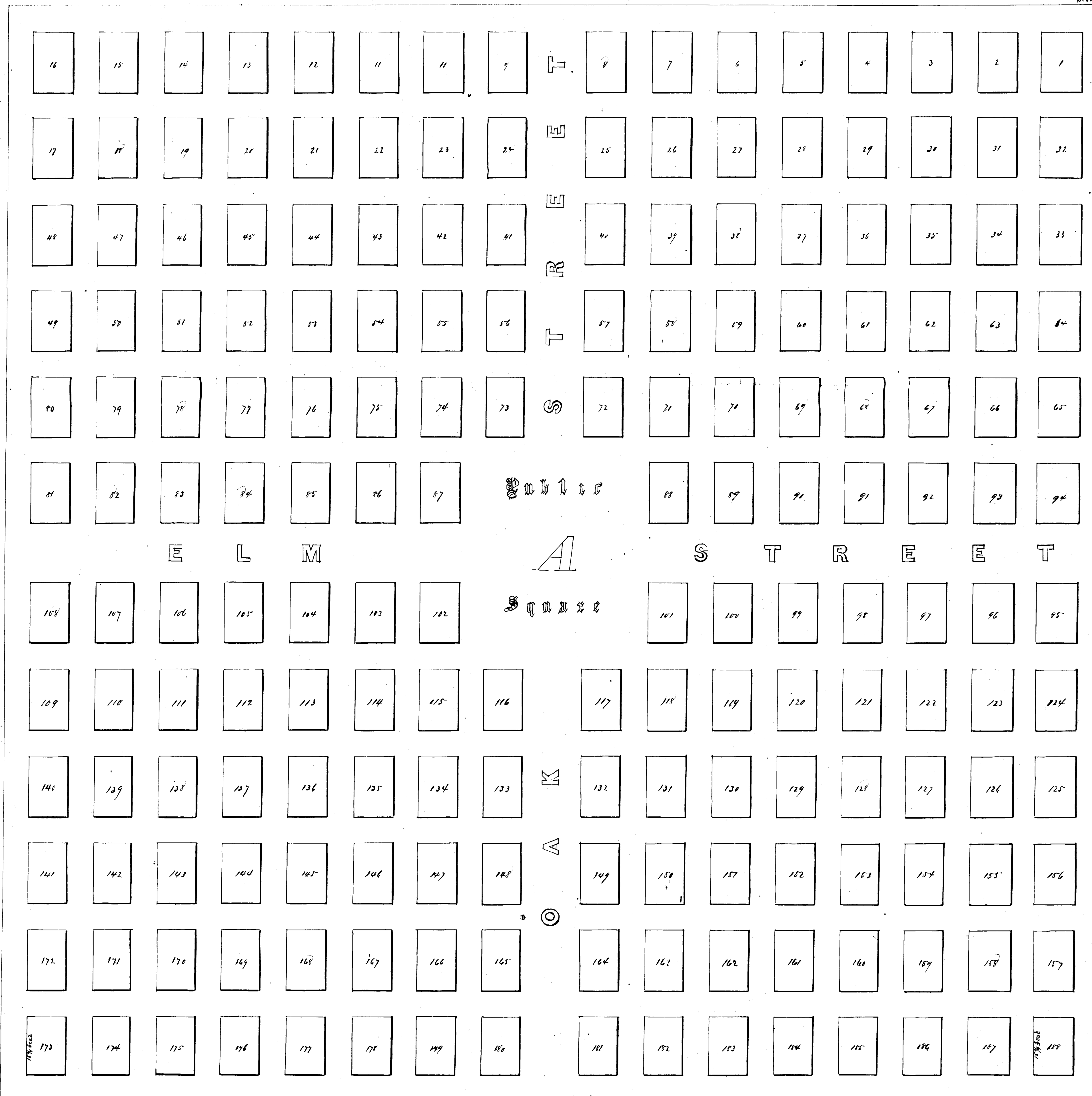


The Cannon Falls Cemetery,

The State of Minnesota,
County of Goodhue,
I, J. O. Dorr,
being duly sworn, do hereby certify, on
oath, that this is a correct plat of
The Cannon Falls Cemetery, as has
been laid out by me in 1868, which
is located upon Block No. 10, City of
Cannon Falls, (which is Block 10 of the Cemetery)
and Block No. 11, City of Cannon Falls,
(which is Block 11 of the Cemetery), the land not
yet having been subdivided into lots
by the Cannon Falls City, Goodhue
County, State of Minnesota, according
to the recorded plat of said Cannon Falls
City, on file in the Office of the Register
of Deeds of said Goodhue County.
The boundaries of said Cemetery
being conformable with the limits
of the aforesaid blocks.

That all lots in said Cemetery
Block 10 are 16 1/2 feet wide and 16 1/2 feet
(16 1/2) feet long north and south to the
line fourth (16 1/2) feet wide east and west,
except only the south tier of lots in said
Block 10 which are 16 1/2 feet wide and 16 1/2 feet
(16 1/2) feet long north and south to the
line and fourth (16 1/2) feet wide east and west.
The streets and alleys are shown 10 feet
wide north and south of the blocks
and alleys are 30 feet long and are often
shown indicated. The plat is signed as
correct and true and I declare the plat
being constructed upon a scale of 1/4 inch
to 10 feet.
