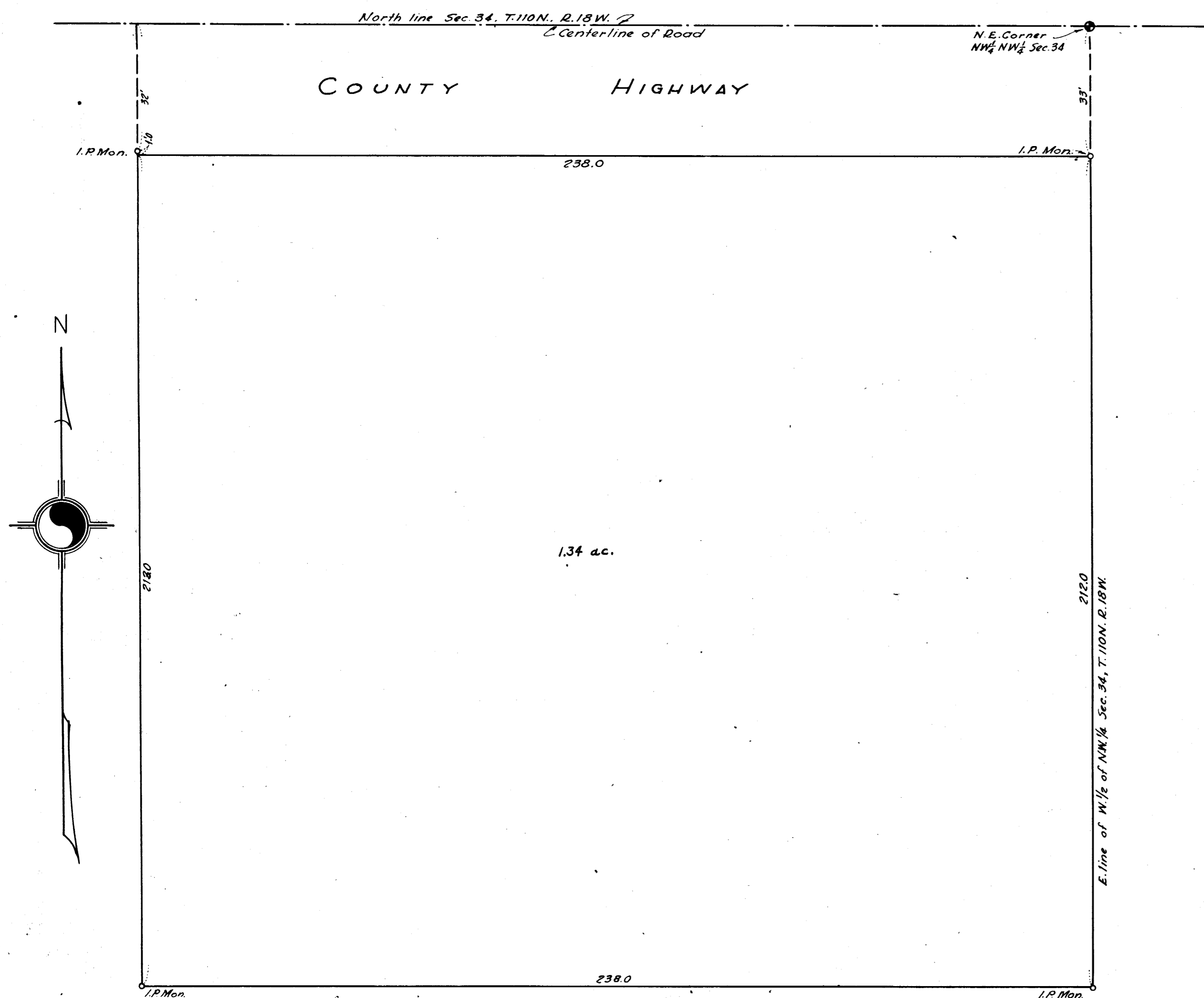


ST. MICHAEL'S CEMETERY

KENYON MINNESOTA.

KNOW ALL MEN BY THESE PRESENTS that The Church of Saint Michael of Kenyon, Minnesota, a corporation organized and existing under the laws of the State of Minnesota, owners and proprietors of the following described tract situate in the State of Minnesota and County of Goodhue, to wit: That part of the west one-half of the northwest one quarter of Section Thirtyfour, Township One Hundred Ten North, Range Eighteen West (W 1/2 of NW 1/4 of Sec. 34, T.110N., R.18W.) described as follows: Beginning at the northeast corner of said west half of said northwest quarter, thence south along the east line of the west half of said northwest quarter two hundred forty five feet (245.0'), thence west parallel to the north line of said section two hundred thirty eight feet (238.0'), thence north parallel to the aforesaid east line two hundred forty five feet (245.0') to the north line of said section, thence east along said north line two hundred thirty eight feet (238.0') to the point of beginning, has caused same to be surveyed and platted and to be known as ST. MICHAEL'S CEMETERY, and hereby dedicate same to cemetery purposes, and do hereby donate and dedicate to the public for its use forever, the highway as shown on the annexed plat. IN WITNESS WHEREOF said corporation has caused these presents to be signed by its proper officers and its corporate seal hereunto affixed this 29th day of November A.D. 1946.
